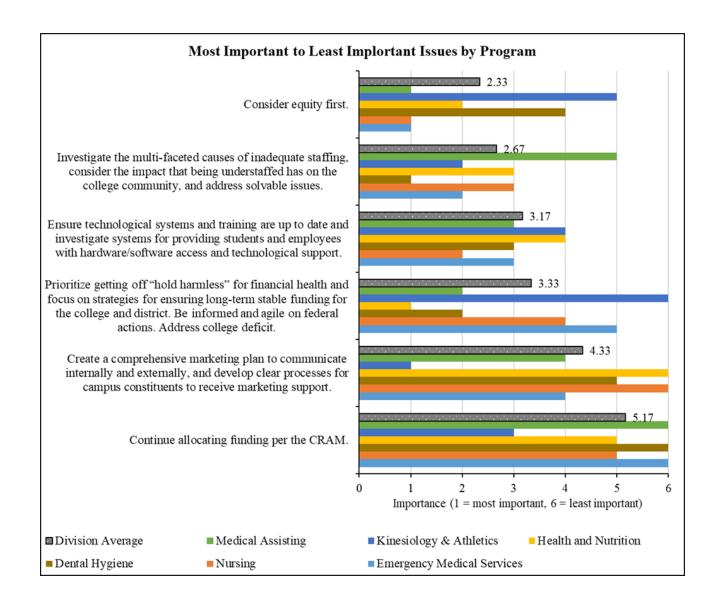

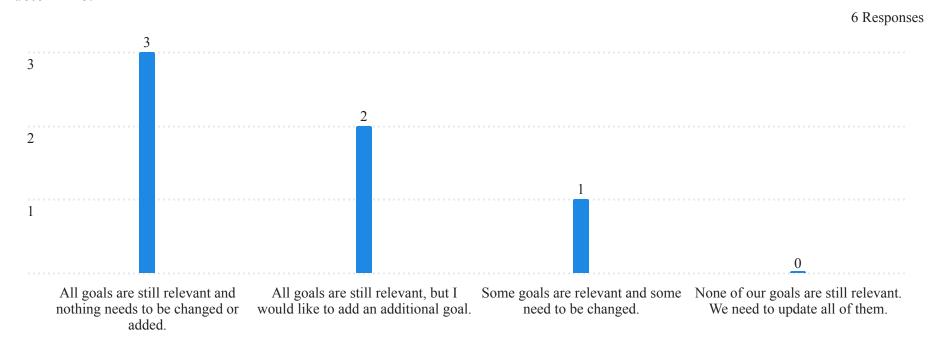

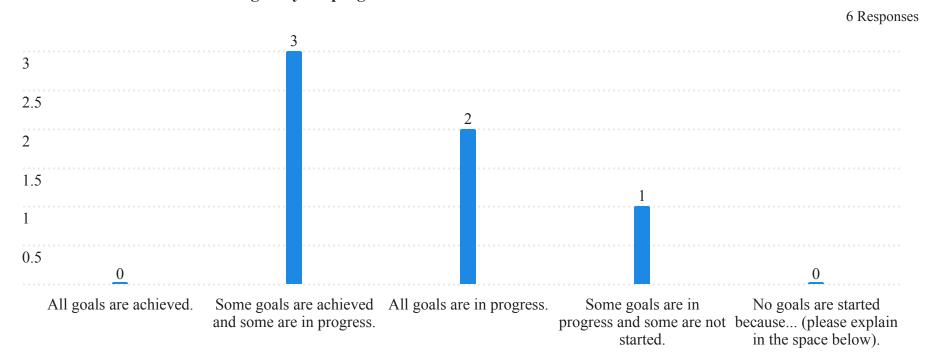

| Dental Hygiene                | Overall, we have met our goals put forth in the dental hygiene program, with success being measured by student's successful completion and graduation form the program, to successfully passing the National Board Dental Hygiene Exam (NBDHE)   |
| Emergency<br>Medical Services | We have created a certificate of Achievement and AS Degree for EMS (specifically EMTs), which they normally do not have.  With the assistance of Pocket Prep (access for the students) we have a higher number of students passing the NREMT the first time around.  |
| Health and<br>Nutrition       | Courses in both Nutrition and Health have fill rates greater than or equal to 73% along with high success rates. We have created a spreadsheet to share with students who plan to continue on in Nutrition while encouraging them to reach out to those schools for additional information. For the Public Health AS-T, we have continued our relationship with CSU East Bay. That relationship includes having one section of their first year seminar course taught on our campus. This was a tremendous opportunity for students in the Public Health AS-T planning to transfer as a junior! Students were able to take the CSU EB course for free. |
| Kinesiology & Athletics       | We have had a substantial increase in AA degree's awarded within our Athletic department.  |
| Medical Assisting             | Creating OER for the entire program is coming along. Most content is created. We are now editing and ensuring all content needed is included.  |

| Dental Hygiene                | Current challenge is hiring of a part-time clinical assistant as support staff. At this time, we do have a full-time clinical assistant, and two faculty members who are working under classified staff to assist in the clinical assistant capacity. I believe the biggest challenge in hiring in the position is its part-time status. Most applicants are looking for a full-time position. Those applicants who have accepted, have later declined due to the position being part-time or not paying enough. In fact, there are plenty of duties which can be assigned for two full-time clinical assistants, as one would focus on front-office duties, student support, and the other would focus on back-office duties, i.e. instrument recirculation, inventory, etc. |
| Emergency<br>Medical Services | Getting the necessary software/equipment in a timely manner. Using the PO process caused many delays in getting equipment and software needed to continue enhancing the EMS program or to make it better, especially for ELL students. Recently found out that we could use the direct disbursement process instead when something is needed quicker.   |
| Health and<br>Nutrition       | The number of degrees granted remain small (Nutrition, n=1 for 2024-2025; Public Health n=10 2024-2045). Speaking to the Nutrition degree path, a change at the national level was made effective 2024 that now requires people wanting to take the registration exam to become a Registered Dietitian Nutritionist (RDN) now requires a Masters degree. While this will ultimately increase the value of the RDN, it does increase the obstacles for potential students.  For the Public Health AS-T, our numbers are still quite small which makes continuing to offer courses like the First Year Seminar in collaboration with CSU EB challenging.  |
| Kinesiology & Athletics       | There is limited financial resources to market our programs effectively. We need more community outreach and recruiting of students.  |

| Dental Hygiene                | Currently, additional resources which most improve student learning processes would be those associated with new and different technologies currently not available in our program. This would include equipment such as: Piezo ultrasonic cleaners which are used within the private practice office. In addition, monitors for the SIM Lab tables would allow students to easily follow class presentations. Currently, the SIM Lab does not work well as a classroom, as the student and teaching pods block the view, preventing students from seeing the lecture screen. Having monitors would allow the student to easily follow lecture, speakers and demonstrations more easily. |
| Emergency<br>Medical Services | We will be putting in a request for Fisdap, a computer software that mimics the NREMT written exams. We can use this for smaller quizzes, exams and study tools so the students have an even higher chance of passing the NREMT the first time around. Most students don't know what to expect with the online, monitored testing software and it causes stress, not helping those that already have test anxiety.   |

#### Nursing

Many of our nursing students work while enrolled in the program, which has been a significant contributing factor to attrition. To improve student retention and learning outcomes, the program plans to provide additional material and technological support that previously required students to pay out of pocket. These resources will include essential clinical and simulation supplies, instructional software, and learning technology to strengthen skill development, enhance preparation for licensure exams, and reduce financial barriers that impact student persistence.

#### Dental Hygiene

Currently the dental hygiene program will be remaining on the standard 18 week schedule.

# Emergency Medical Services

Our program is required to have a certain number of hours in the classroom (didactic and laboratory) as well as clinical/externship time. A compressed schedule makes it harder for the students to work around their employment to schedule those times. As well as, we are already running long lec/lab days and adding time to those days will make it more difficult on the student to retain the necessary information.

Adding additional days will be difficult to work around CC Fire, Hayward Fire and any other entity that rents out the facility. We also need a 1:6, teacher to student ratio while doing skills, and currently we depend on volunteers that work in the field.

Fire, currently works outside of the semester to get their required time in. I will be proposing the same for EMS so the students have their weekends for employment and study time.

| Health and Nutrition    | The courses in our discipline are typically 3 units without labs which makes the conversion to the compressed calendar an easier task. Less clear is how the new block schedule and college hour will impact course assignments.  |

| Medical Assisting       | I don't anticipate any challenges except room scheduling. We have been running 9- and 12-week classes, so we are used to condensing our courses and it has worked well. I have modified curriculum so students can obtain a COA within a year. This along with the program being completely ZTC/OER should increase enrollment and success rates. |
| Nursing                 | Nursing will not be on the compressed calendar system   |
